This approach to curriculum design has ensured the development of productive human resources and helped to a great extent in enhancing the employment potential of the students. ICT facilities have been provided for better teaching-learning outcomes and all the departments have been equipped with panel boards and LCD projectors enabling technologydriven pedagogical transactions. The student progression for the past five years has been encouraging. Above 100 students passed in NET/ SET/ GATE and other competitive examinations. Students have won awards/ medals for their outstanding performances in sports/ games/ cultural activities, such as powerlifting, weight lifting, softball, poster making, clay modeling, etc. Student representatives play important role in the planning and organizing of college day events, awareness programs, conducting Fresher's day, Management meets, Independence Day, Republic Day, Teacher's Day, Blood Donation camps, Clean & Green program, etc, and also represented as members in Institution Innovation Council of MHRD, Anti-ragging Committee, etc.

The University had to remain closed even after summer few years for want of groundwater. During 2020-21 top leadership of the University has taken this problem very seriously and successfully convinced the State government of AP to build check dams to recharge groundwater underwater harvesting program. In total 1 large check dam and 3 recharge basins were built in low-lying areas of the University with whatever rainfall that was received during the year was saved successfully and during 2021-22 there has been no water shortage and the entire campus worked even during summer to adjust lost academic year during Covid-19. University was also facing a Drinking water shortage for a long time. Top leadership also pursued this issue very seriously and successfully erected a water purifier plant just behind the administrative block which is now catering to the drinking water for the entire administrative staff of the University and also one of the largest departments of the University. A solar plant was erected successfully within the University campus pending about Rs 2.56 crores under RUSA grants with the generation of 1.5 megawatt saving Rs 40,00,000/- Lakhs for University towards electricity bills. 6.4 - Financial Management and Resource Mobilization**6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources**

The Vice-Chancellor, with the assistance of officers concerned, Deans, and faculty members, approaches the funding agencies like State Government, Central Government, UGC, ICSSR, ICMR, CSIR, Department of Science and Technology, and also Philanthropists for the development of Research Laboratories, Infrastructural facilities for promotion of teaching-learning and research and development in the University. The University has been successful in getting increased grant-in-aid from the government during the last five years. Likewise, the University could get a good amount of research grants from the funding agencies. The University could also mobilize funds from the Alumni for

establishing RO plants near the hostels to provide clean drinking water to the students. There is a Finance Committee to look after and prepare annual budgets and annual accounts and approve the same quarterly. The Finance Committee presents the financial matters after careful scrutiny to the Executive council for its final approval. The Academic Senate Chaired by the Vice-Chancellor also monitors the generation of funds and their effective utilization. The State Audit Department, Govt. of A.P. audit the finances of the University from time to time every year and also overall audit of the accounts by the external auditors like Auditor General for every 2-3 years.
